

## Statement of Comparability for university degrees from Nepal: Checklist

### You can apply for a Statement of Comparability for the following degrees

- Doctoral degree (PhD)
- Master's degree
- Postgraduate diploma, postgraduate certificate
- Bachelor's degree

The ZAB can only issue a Statement of Comparability if your degree program and university were recognized at the time of your graduation. For more information visit [www.ugcnepal.edu.np](http://www.ugcnepal.edu.np)

### The ZAB does not issue Statements of Comparability for the following degrees

- National diploma / national technician certificate
- Graduate diploma / graduate certificate
- Professional graduate certificate / associate degree
- Diploma in engineering / advanced diploma in engineering

These degrees are below the level of the first regular university degree in Nepal or are classified as vocational/technical qualifications in Germany. ## Documents for the application

Only submit photocopies of your documents. The only original document we need is the application form with your signature.

Do not submit translations.

University degree to be evaluated	
<input type="radio"/>	<p><b>University diploma</b> (final or provisional degree certificate) in English</p>
<input type="radio"/>	<p><b>Transcript of records for the entire degree program</b> (a university-attested copy of the mark sheets / consolidated mark sheets or official transcripts) in English</p> <p>in an unopened envelope sealed by the university</p> <p><u>or</u></p> <p>submitted directly by your university (registrar / evaluation section / board of examination) to our email address <a href="mailto:zabservice@kmk.org">zabservice@kmk.org</a></p>
<input type="radio"/>	<p><b>Certificate from your university stating your mode of study</b> (e.g. open and distance learning / online learning) in English</p> <p><u>only if</u> your mode of study is <u>not</u> stated in your documents</p>

○	<p><b>Certificate from your university confirming the completion of a final thesis</b> in English</p> <p><u>only if</u> you completed a final thesis (dissertation / master thesis / project / research project) and this is <u>not</u> stated in your documents</p>
○	<p><b>Documents regarding transferred credit</b> in English</p> <p><u>only if</u> you transferred credit that counted toward your degree, e.g. from another degree program or vocational training</p> <p>Example: If you transferred to another university, you have to submit the transcript of records from your first university as well.</p>

<b>Previous university degrees</b>	
	<p>Example: If you want us to evaluate your master's degree, you have to submit the following documents regarding your bachelor's degree as well.</p>
○	<p><b>University diploma</b> in the original language</p> <p><u>and</u></p> <p>○ <b>Transcript of records <u>or</u> diploma supplement</b> in the original language</p> <p><u>only if</u> you have any previous university degrees</p>
○	<p><b>Certificate from your university stating your mode of study</b> in the original language</p> <p><u>only if</u> the mode of study of any previous university degrees is <u>not</u> stated in your documents</p>

○	<p><b>Certificate from your university confirming the completion of a final thesis</b> in the original language</p> <p><u>only if</u> you completed a final thesis for any previous university degrees and this is <u>not</u> stated in your documents</p>
○	<p><b>Documents regarding transferred credit</b> in the original language</p> <p><u>only if</u> you transferred credit, e.g. from another degree program or vocational training, that counted toward any previous university degrees</p>

Secondary school	
○	<p><b>Secondary school graduation certificates for grades 10 and 12</b> (Certificates of Secondary and Higher Secondary Education School / Higher Secondary Education Board Certificate / Proficiency Certificate / Leaving Certificate or upper secondary school equivalent) in English</p>

Miscellaneous documents	
○	<p><b>Identity document</b> valid passport</p>
○	<p><b>Proof of name change</b> (e.g. marriage certificate) in the original language</p> <p><u>only if</u> your name has changed</p>
○	<p><b>Refugee ID or asylum notice</b></p> <p><u>only if</u> you are recognized as a refugee or an asylum seeker and do <u>not</u> agree to the ZAB verifying the authenticity of your documents by contacting any relevant institutions</p>

## Additional information

### Additional documents

If we need additional documents or information to evaluate your university degree, we will contact you by email. Please check your email regularly.

We reserve the right to ask you to submit original documents if necessary.

### Photocopies

Only submit photocopies of your documents. You can make these photocopies yourself. The only original document we need is the application form with your original signature. Do not submit any other original documents unless we explicitly ask you to do so. We assume no liability for unsolicited original documents.

Make sure your photocopies are legible and complete.

Do not submit folders or plastic sheet protectors.

### Translations

Only submit translations if they are listed in the checklist.

A degree is evaluated based on the documents in the original language, even if we ask for translations. Therefore, do not submit translations without submitting the documents in the original language as well.

Your documents can be translated in or outside of Germany as long as the translator is certified for the respective language, authorized, or publicly sworn. You can search for translators in Germany in the state administrations of justice's database of translators and interpreters (Dolmetscher- und Übersetzerdatenbank der Landesjustizverwaltungen).
