

Statement of Comparability for university degrees from **Tunisia**: Checklist

You can apply for a Statement of Comparability for the following degrees

- Licence Fondamentale
- Licence Appliquée
- Mastère de Recherche
- Mastère Professionnel
- Diplôme National d'Ingénieur
- Maîtrise
- Doctorat

The ZAB can only issue a Statement of Comparability if your degree program and university were accredited or recognized at the time of your graduation. For more information visit http://www.mes.tn

The ZAB does <u>not</u> issue Statements of Comparability for the following degrees

- Diplôme d'Etudes Universitaires Générales (D.E.U.G.)
- Diplôme des Etudes Universitaires de Premier Cycle (DEUPC)
- Baccalauréat

The following degrees are not equivalent to a German bachelor's degree

The ZAB can issue a Statement of Comparability for the following degrees, but they will be evaluated as below the level of a German bachelor's degree. They correspond to a qualification from a German vocational school (Berufsfachschule).

- Diplôme d'Etudes Supérieures de Technologie (D.E.S.T)
- Diplôme de Technicien Supérieur (D.T.S.)
- Diplôme Universitaire de Technologie (D.U.T.)

Documents for the application

Only submit <u>photocopies</u> of your documents. The only original document we need is the application form with your signature.

Do <u>not</u> submit translations.

Application form	
0	Application form for a Statement of Comparability with your original signature
	If you want us to evaluate more than one university degree, fill in a separate application form and submit a separate application for each degree.

University degree to be evaluated	
0	University diploma (Diplôme) in the original language
0	Transcript of records for the entire degree program (Relevé de notes) in the original language
0	Certificate of equivalence (Muqarrar mu'adala) only if the university degree was awarded by a private university
O	Documents regarding transferred credit in the original language only if you transferred credit that counted toward your degree, e.g. from another degree program (e.g. D.T.S., D.U.T., D.E.U.G.) or vocational training Example: If you transferred to another university, you have to submit the transcript of records from your first university as well.

Previous university degrees		
	Example: If you want us to evaluate your master's degree, you have to submit the following documents regarding your bachelor's degree as well.	
0	University diploma in the original language	
0	and Transcript of records or diploma supplement in the original language	
	only if you have any previous university degrees	
0	Documents regarding transferred credit in the original language	
	only if you transferred credit, e.g. from another degree program or vocational training, that counted toward any previous university degrees	

Secondary school	
0	Secondary school graduation certificate (Baccalauréat) in the original language

Miscellaneous documents	
0	Identity document passport or identity card
0	Proof of name change (e.g. marriage certificate) in the original language only if your name has changed

O Refugee ID or asylum notice

only if you are recognized as a refugee or an asylum seeker and do not agree to the ZAB verifying the authenticity of your documents by contacting any relevant institutions

Employment contract or written confirmation of employment from your future employer in Germany

only if the Statement of Comparability is required to apply for a Blue Card visa

Additional information

Additional documents

If we need additional documents or information to evaluate your university degree, we will contact you by email. Please check your email regularly.

We reserve the right to ask you to submit original documents if necessary.

Photocopies

Only submit photocopies of your documents. You can make these photocopies yourself. The only original document we need is the application form with your original signature. Do not submit any other original documents unless we explicitly ask you to do so. We assume no liability for unsolicited original documents.

Make sure your photocopies are legible and complete.

Do not submit folders or plastic sheet protectors.

Translations

Only submit translations if they are listed in the checklist.

A degree is evaluated based on the documents in the original language, even if we ask for translations. Therefore, do not submit translations without submitting the documents in the original language as well.

Your documents can be translated in or outside of Germany as long as the translator is certified for the respective language, authorized, or publicly sworn. You can search for translators in Germany in the state administrations of justice's

database of translators and interpreters (Dolmetscher- und Übersetzerdatenbank der Landesjustizverwaltungen).
